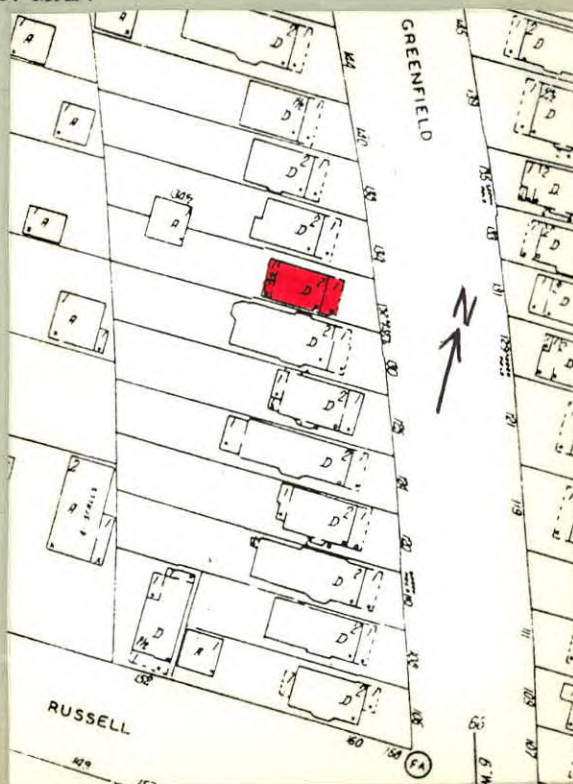

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located four blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):  
Two and a half story frame residence with front facing gable roof. Full-width pedimented gabled porch. Shingled base with tapered shingled end porch pedestals. Tapered square wood supports. Center support, slender square Doric style. Stick balustrade. Entablature with extending cornice. Glass and wood paneled door. First floor three-part window;

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A gabled frame residence with Colonial Revival styling. Greenfield Street extends from Amherst Street to Main Street, paralleling the Belt Line Railroad. Although Greenfield Street was deeded to the city in 1889, it was laid out in 1886 by the Parkside Land Company, which had purchased the land between Amherst Street and West Oakwood Place from two major landowners, Elam R. Jewett and Washington Russell. A street very similar in configuration appears in Olmsted's early 1870's maps of "The Parkside." Greenfield follows Olmsted's plan for providing easy access to major streets while being too narrow for extensive commercial development, although some commercial buildings can be found near Main Street.

18. (cont.) single hung single light with leaded top light. Second floor center bay has two small square windows, two single light casements each. Plain window surround with curved low relief panel below. Enc bays have double hung windows. Four vertical light top lights. Plain window surround. Pedimented gable has flared base to form cornice for second floor. Band of trim below cornice. Gable has bargeboard with curved ends. Gable has paired double hung window. Three vertical lights in top light. Pediment shaped window head with center keystone.
