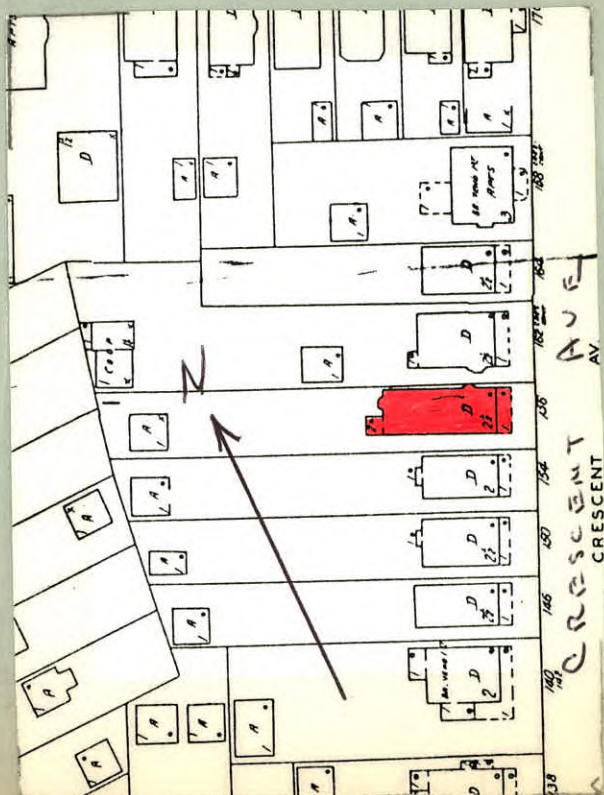

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):
Two and a half story with hip roof. Exposed rafter tails and brackets under roof eaves. Full-width porch has flat roof and entrance projection. Square doric supports and spindle balustrade. Glass paneled door with leaded sidelights. Tri-part first floor 1/1 window. Shingle second floor. Semi-hexagonal second floor bay, 1/1 windows with entablature window head. Porch

19. DATE OF INITIAL CONSTRUCTION: 1910 door located in small semi-hexagonal bay. Hip roof
ARCHITECT: _____ dormer with flared eaves.
BUILDER: _____ Exposed rafter tails. Pair of 1/1 windows.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A typical frame Buffalo residence with Craftsman and Prairie School styling. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
