

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS: (Indicate if building or structure is in an historic district)

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known): Two and a half story American Four Square with Craftsman style details. Hip roof with exposed rafter tails under projecting eave. Full-width hip roof wing. Projecting eave with exposed rafter tails. Brick end piers. Curved span between supports. Three single light windows. Brick first floor. Second floor has two 8/1 windows. Stucco second floor. Hip roof dormer 9. DATE OF INITIAL CONSTRUCTION: 1911 with exposed rafter tails under eave. Two 6/1 light

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A typical American Four Square with Craftsman style details applied. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood Place to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
