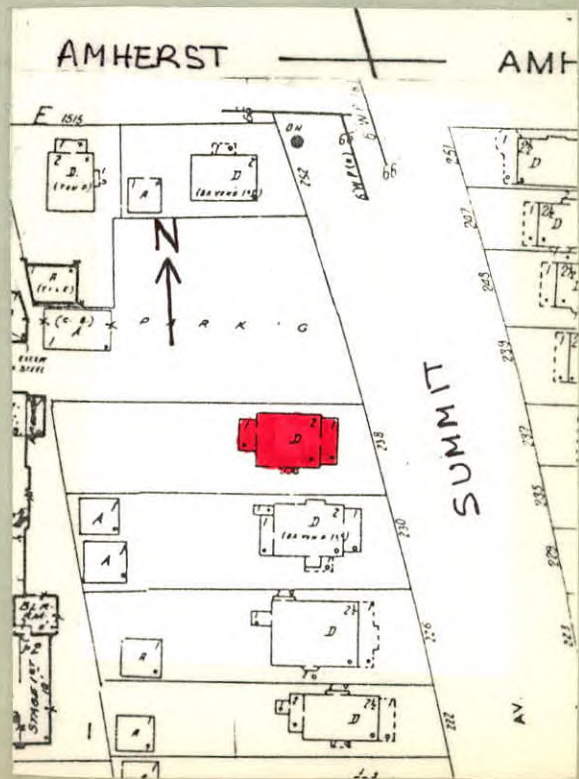

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story Colonial Revival style. Front facing gable roof with cornice returns. Exposed rafter tails under raking cornice. Full-width flat roof wing has paired windows, double sash, twelve light windows with transom. Exterior central chimney on second floor flanked by 8/1 windows with entablature window head. Window shutters. Quarter round windows flank chimney in gable. South

**SIGNIFICANCE**

19. DATE OF INITIAL CONSTRUCTION: 1926  
 ARCHITECT: entrance with upper porch stick balustrade.  
Lighted door. Gabled dormer with cornice returns,  
 BUILDER: pair of 4/1 windows.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A typical Colonial Revival style residence of 1920's, situated on a narrow urban lot. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood Place to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
