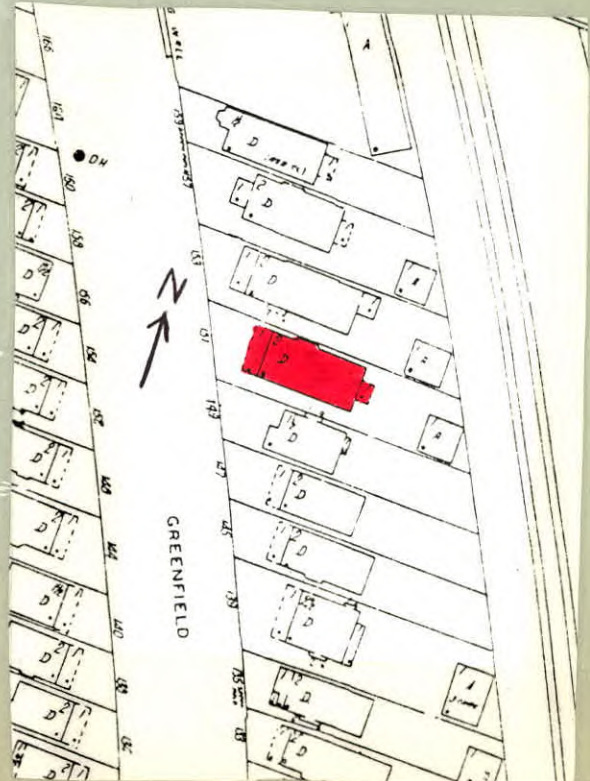

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located four blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):
 Two and a half story frame with hip roof. Extending eave with stick styled brackets at center and ends of eave. Full-width flat roof porch. Rough cut, regular course stone base. Paneled tapered square supports. Wood panel rail with slender rectangular cut-outs. Entablature with modillions under extending eave. Upper porch balustrade imitates lower porch. Glass and wood paneled door with 3/4 leaded sidelights.

SIGNIFICANCE
 19. DATE OF INITIAL CONSTRUCTION: 1922
 ARCHITECT: Double hung 1/1 lights. Top light has horizontal and vertical band. Second floor semi-hexagonal bay. Double hung 1/1 windows. Plain window surround. Right bay has 9-light wood paneled door. Band of trim below eave. Hip
 BUILDER: Three-part first floor window.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: roof dormer has three-part window. Double hung with top light having vertical and horizontal band of trim.
 A frame residence influenced by American Four Square form retains its original porch; many residences of this type have had porch modified. Greenfield Street extends from Amherst Street to Main Street, paralleling the Belt Line Railroad. Although Greenfield Street was deeded to the city in 1889, it was laid out in 1886 by the Parkside Land Company, which had purchased the land between Amherst Street and West Oakwood Place from two major landowners, Elam R. Jewett and Washington Russell. A street very similar in configuration appears in Olmsted's early 1870's maps of "The Parkside." Greenfield follows Olmsted's plan for providing easy access to major streets while being too narrow for extensive commercial development, although some commercial buildings can be found near Main Street.
