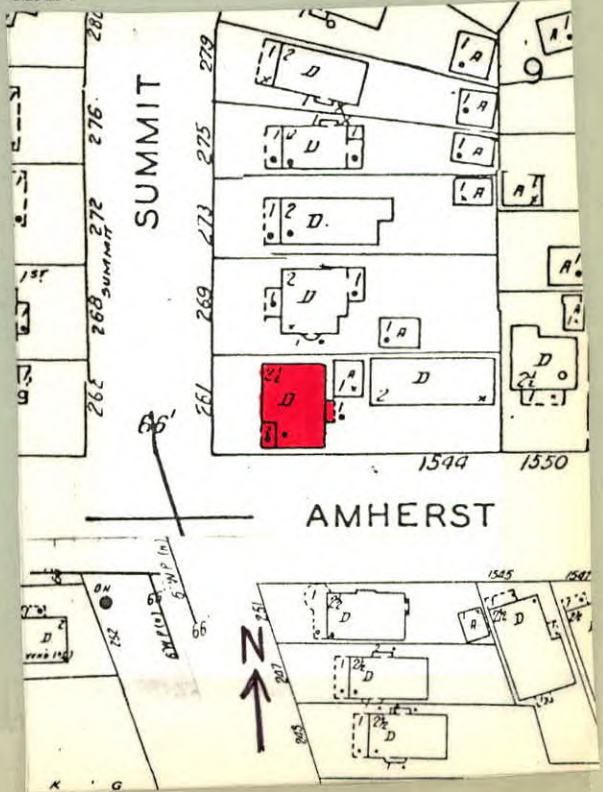

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a small sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):  
Two and a half story multiple residence with hip roof. End bay first and second floor has recessed porch. Square corner support with spindle balustrade. Dentils under eave. Projecting entrance has glass paneled door, flanked on one side by a pair 6/6 windows. Second floor glass paneled porch door.

SIGNIFICANCE Pair 2/2 windows. First floor facade has small rectangular window, leaded, flanked on one side by pair 1/1 windows. First ARCHITECT: \_\_\_\_\_ and second floor 1/1 windows with entablature window surround. Gabled dormer has three 1/1 BUILDER: \_\_\_\_\_ windows.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A frame multiple residence situated on corner lot. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood Place to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
