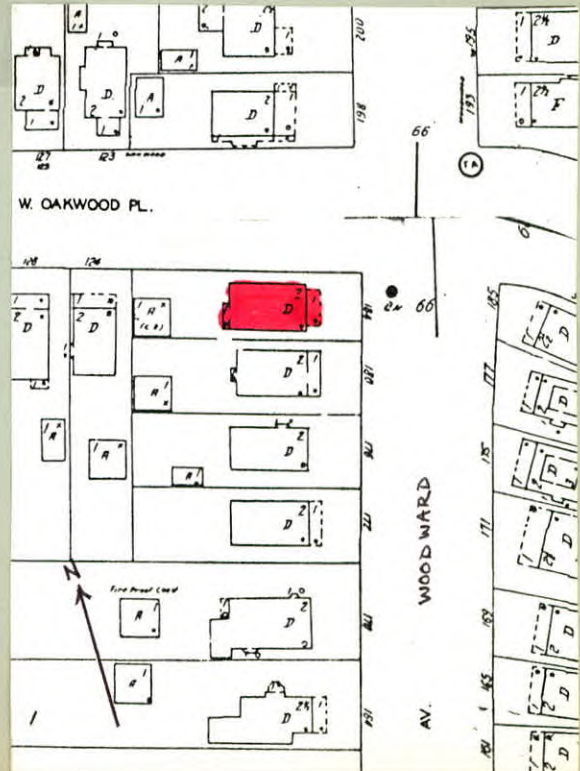

Building is situated on a standard sized corner lot within Olmsted's Parkside subdivision. House is located one block from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story with Craftsman style influence. Side gable roof with extending eaves supported by volute brackets. Projecting entrance has flat roof. Multi-light window on first floor flanking entrance. Square-headed 6/1 light window on first floor. Second story has a set of paired 1/1 light windows with plain surround and capping cornice window head. Gabled dormers. Bargeboard.

- SIGNIFICANCE**
19. DATE OF INITIAL CONSTRUCTION: 1907 Decorative rafter tails under eave. South side has a pair of boxed bay windows, shed roof on first floor. Second floor triangular oriel.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: Typical example of residence with the Craftsman style applied. Woodward Avenue runs parallel to Parkside Avenue and extends from Humboldt Avenue to the northwest portion of Crescent Avenue. This street appears on Olmsted's early 1870's maps of "The Parkside," although it is less curvilinear than originally planned. Portions of Woodward Avenue (originally called Davis Avenue) were deeded to the city by five different owners between 1887 and 1892; except for the section north of Amherst, this was done when comparable sections of Crescent Avenue were deeded. Following Olmsted's rule for a suburban street, Woodward Avenue does "not lead with special directness toward town."
