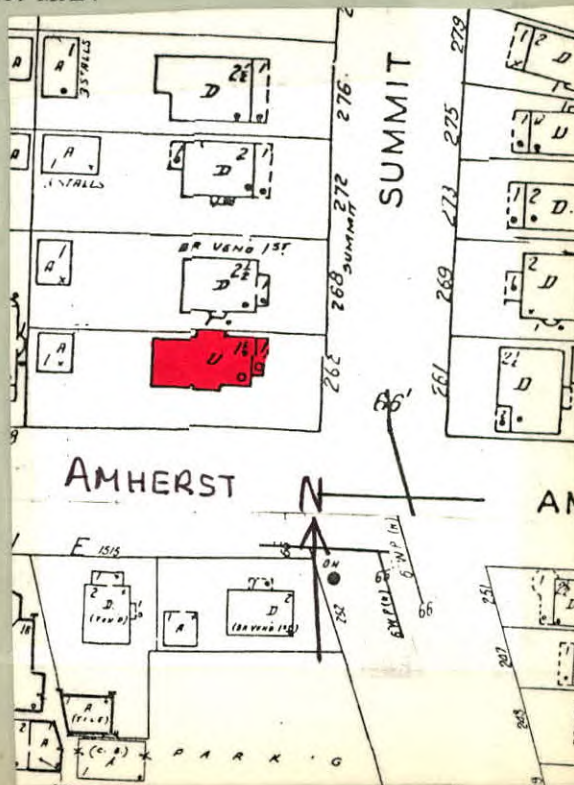

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and northeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two story Craftsman style. Front facing gable roof. Bargeboard with flared ends supported by triangular knee brackets. Partial-width gabled porch. Bargeboard. Tapered square supports and stick balustrade. Lighted door. Double sash, lighted, porch doors. Second floor has a pair Palladian windows flanking square single light windows. South side gabled dormer. Bargeboard

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A good example of two story Craftsman style. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood Place to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
