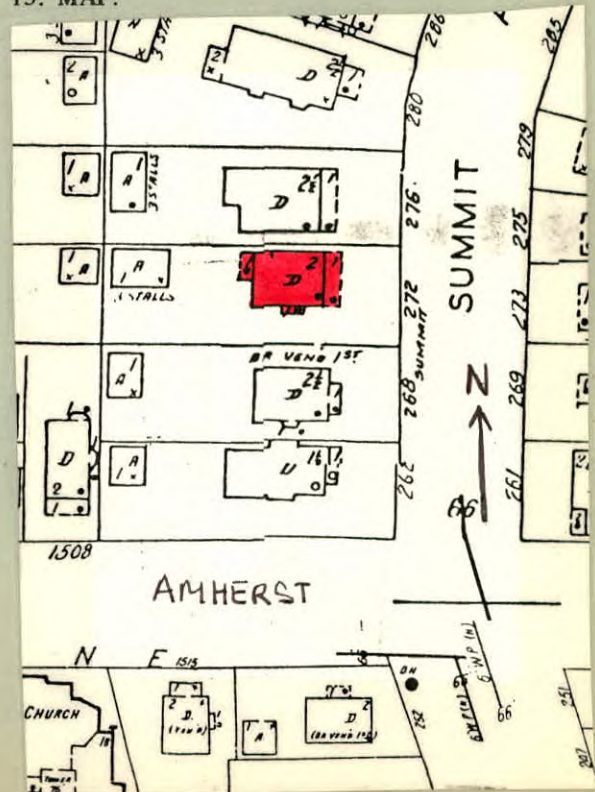

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and northeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story American Four Square form with Craftsman style details. Hip roof with flared eaves. Exposed rafter tails under projecting eave. Full-width hip roof wing. Flared projecting eaves with exposed rafter tails. Three-part single light windows flanked by slender light with square transom. Second floor end bay has boxed bay window. Three single lights with leaded transom.

19. DATE OF INITIAL CONSTRUCTION: 1916

ARCHITECT: Center small rectangular window flanked on one side by 1/1 window. Hip roof dormers. Flared eaves with exposed rafter tails under projection.
 BUILDER: Pair rectangular six-light windows. Side entrance. Hip roof entrance porch.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: Square supports with curved braces at capital. Wood paneled door.

An American Four Square with Craftsman styling applied. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood Place to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
