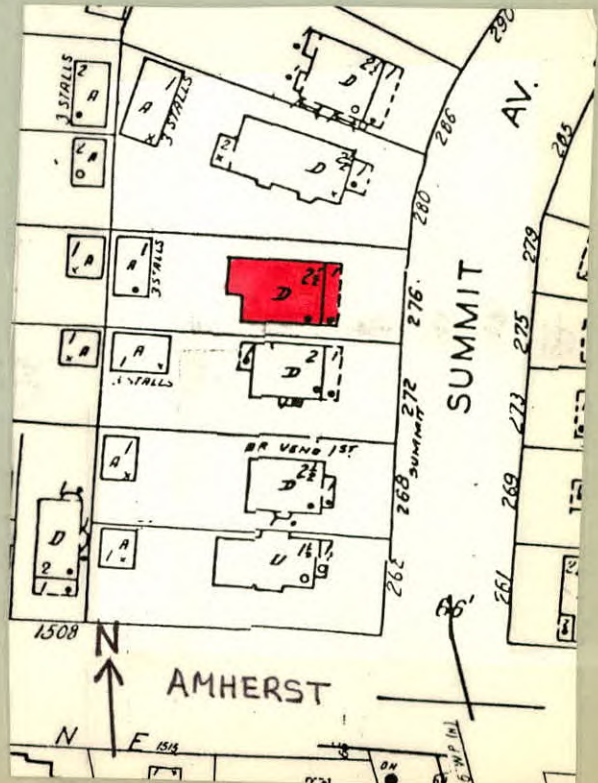

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and northeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story American Four Square form. Steep pitched hip roof with flared projecting eave. Full-width hip roof porch. Engaged Doric columns flank openings. Baluster balustrade. Clapboard first floor. Second floor 8/1 windows with louvre shutters. Stucco second floor. Gabled dormer with flared ends and end return. Dentils. Three-part window; center 6/1 with 2/1 sides.

19. DATE OF INITIAL CONSTRUCTION: 1899

- Projecting window hood supported by brackets.
Side entrance has Doric supports supporting hip roof hood. Glass and wood paneled door.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A typical American Four Square form with flared eaves and Classical details applied. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood Place to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
