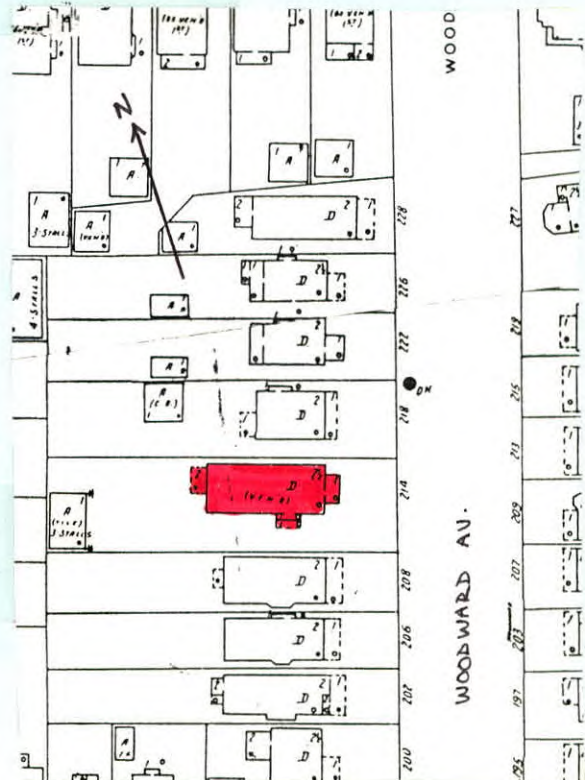

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located one block from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story American Four Square. Hip roof with exposed rafter tails under extending eaves. Partial width first floor wing has horizontal band of paired single light window with 4 light transom. Entablature at roof line. Upper porch paneled rail. First floor 6/1 light windows with relieving arch. Second floor has 8/1 light windows flanking multi-light porch door. Hip roof dormer with exposed rafter tails under eave. A pair of 6/1 light windows. South side has entrance. Metal entrance hood with ornamented glass border.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A typical American Four Square. Woodward Avenue runs parallel to Parkside Avenue and extends from Humboldt Avenue to the northwest portion of Crescent Avenue. This street appears on Olmsted's early 1870's maps of "The Parkside," although it is less curvilinear than originally planned. Portions of Woodward Avenue (originally called Davis Avenue) were deeded to the city by five different owners between 1887 and 1892; except for the section north of Amherst, this was done when comparable sections of Crescent Avenue were deeded. Following Olmsted's rule for a suburban street, Woodward Avenue does "not lead with special directness toward town."
