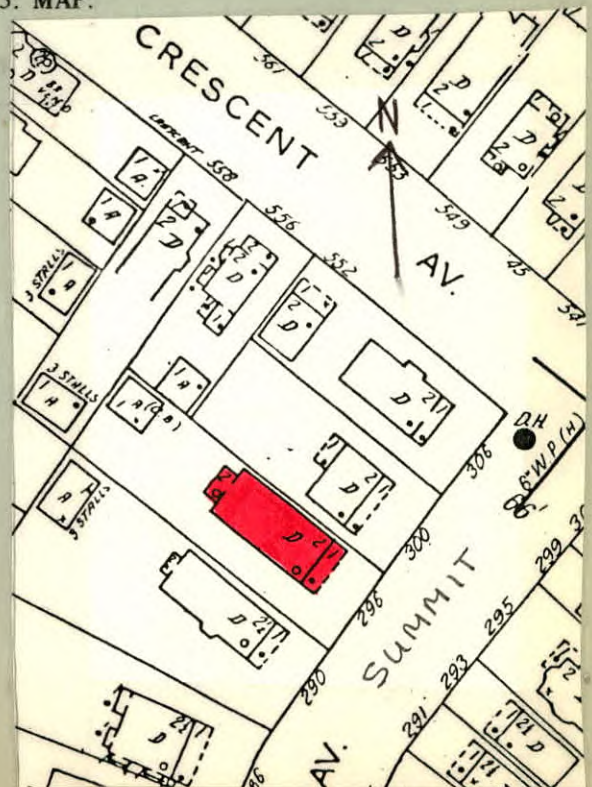

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and northeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):
 Two and a half story American Four Square type. Hip roof with extending eaves. Full-width flat-top hip roof porch. Rough cut, regular course stone base and end piers. Small tapered square supports. Stick and paneled rail. Projecting entrance has lighted door with 6 light sidelights. Tri-part first floor window; 10/1 center with 4/1 sides. Second floor

SIGNIFICANCE glass and wood paneled porch door. Boxed bay has three part window,
 19. DATE OF INITIAL CONSTRUCTION: 1916
 ARCHITECT: _____
 BUILDER: 10/1 center with 4/1 sides. Hip roof dormer with extending eaves. Three part 6 light windows.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A typical vernacular version of the American Four Square. Summit Avenue is a truncated north-south street, located between Woodward and Crescent Avenues and extending from West Oakwood Place to the northern section of Crescent Avenue. A similar street, ending south of Jewett Avenue, appears in Olmsted's early 1870's maps of "The Parkside." Summit Avenue was deeded to the city in 1889, except for the small section between Amherst and Crescent which was deeded in 1892. This street follows Olmsted's rule that it "not lead with special directness toward the town."
