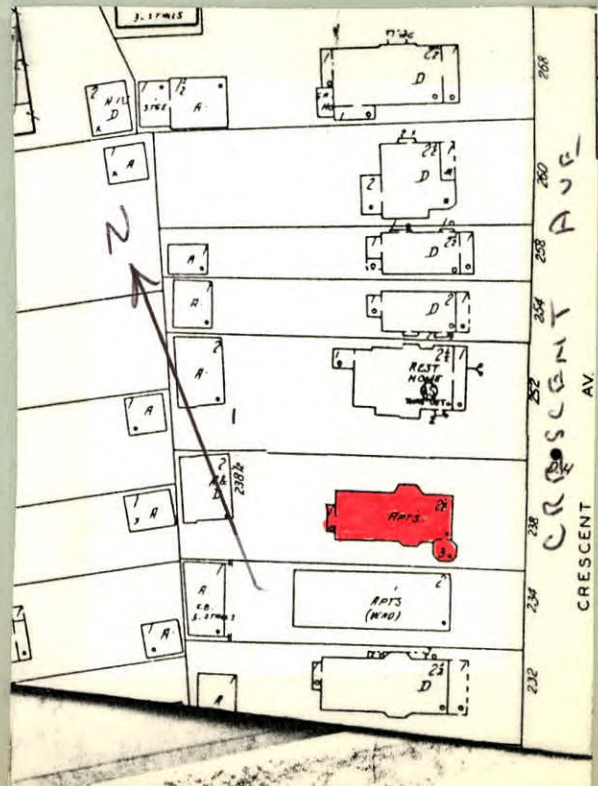

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located three blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story Queen Anne style. Hip roof. Front facing gabled facade. Glass and wood paneled door with slender leaded sidelights. Concave entrance hood. First floor 1/1 windows. Second floor tri-part window; center window top light has round arched tracery, 6/1 side windows. Two and a half story tower; semi-hexagonal first and second floor with polygonal third story and roof. First and second

19. DATE OF INITIAL CONSTRUCTION: 1900  
ARCHITECT: \_\_\_\_\_ story 1/1 windows. Third story has rectangular multi-light center window with flanking square windows.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A good example of Queen Anne style with its use of towers on front and side. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
