September 15-16, 1988

The Council on Nursing Research held its third meeting on July 18-19, 1988. The following summarizes the current activities.

I. SEPTEMBER JOURNAL

A. Editors - Willa Doswell and Mary Evans are the Co-Editors.

B. Contents

1. Three papers, authored by Levin, Plummer and Scharf.
2. Clearinghouse of Nursing Research.
3. Report on Rounds I and II of the Delphi Survey of Nursing Priorities for New York State.
4. Summary of the April 30-May 1 Research Conference to be prepared by Cathryne Welch.

C. Editorial

The editorial will reflect the new look of the Journal and will announce its new peer-reviewed status.

II. DELPHI SURVEY OF NURSING RESEARCH PRIORITIES

A. The lost cards from Round I have been found and were entered into the computer. There were no significant differences noted from the original statements entered.

B. Participants: Round I - 2595
Responses: Round I - 872 (34%)

C. Participants: Round II - 2623
Responses: Round II - 985 (38%)

D. Analysis of Round II is completed. Round III was sent early in August to complete the 1988 Delphi Survey.

Participants: Round III- 2659
Responses: Round III- 868 (as of 9/6)

III. ORAL HISTORY PROJECT

The Council has completed the six planned interviews. A publication including the monographs, transcripts, biographical data and references for the six subjects is being prepared.

IV. DISTINGUISHED NURSE RESEARCHER AWARD

The Council members reviewed 5 nominees for the seventh Distinguished Nurse Researcher Award to be presented by the Foundation of the New York State Nurses Association, Inc. The selected awardee is Dr. Madeline Schmitt from the University of Rochester.

May 18-19, 1988

The Council on Nursing Research held its second meeting on March 31, 1988. A two-day meeting is scheduled for July. The following summarizes the Council's current activities:

I. CLEARINGHOUSE ABSTRACTS

A second request for abstracts was sent on March 18, 1988, extending the deadline to May 1, 1988 and announcing that the Clearinghouse would be published in the September Journal.

As of April 25, 1988, 64 abstracts had been received. Several were returned to the authors requesting that they utilize the abstract protocol or develop a one-page abstract including the data requested on the protocol.

II. CONVENTION PLANS

A. Program

Two programs are planned - "Utilizing Nursing Research in a Clinical Setting" and "The NYSNA Oral History Project: A Synopsis."

B. Poster Sessions

A second notice for Poster Session abstracts was sent the end of April. As of April 25, 1988, 2 abstracts had been received.

C. Council Booth

A bibliography of nursing research journals will be prepared as a handout for the booth. Nursing research consultation will again be available.

III. LIAISON WITH THE FOUNDATION OF THE NEW YORK STATE NURSES ASSOCIATION

A. Distinguished Nurse Researcher Award

Four nominations have been received but three of the four are incomplete at this time.

B. Research Conference, "Directions for Nursing Research in New York State, April 30-May 1, 1988"

The Council is co-sponsoring this Conference.

IV. SEPTEMBER JOURNAL

Willie Doswell and Mary Evans will serve as co-editors of this issue of the Journal. The Council on Nursing Research will be constituted as the editorial board for this issue. In addition to peer reviewed articles on reports of nursing research studies or papers related to issues in nursing research, the September Journal will contain the Clearinghouse and a report on the Council activities.

V. DELPHI SURVEY - 1ST ROUND

The first round request for participation in a Delphi Survey to establish research priorities in New York State was sent on February 8, 1988. All NYSNA members with master's or doctoral education were solicited (N=2595).

A total of 872 responses were received (33.6%). The cards were sent to the Council members for sorting and categorization.

594 cards were lost in the mail. A post office search was not successful in locating this mailing. This loss will be reported in the survey discussion. It is believed that these cards would not differ significantly from the other 2022 cards and, therefore, the loss should not affect the research results.

Each Council member is computerizing her data. As soon as the categorization is completed a second round to all of the original 2595 participants will be sent.

September 17-18, 1987

The Council on Nursing Research held its fourth meeting on July 8-9, 1987.

I. ORAL HISTORY PROJECT

Emily Creevey was interviewed by Nancy Noel on July 7, 1987 in the Media Center of the SUNY Albany campus. This was the sixth and final interview for this first oral history project. The monograph and transcript are in draft status.

II. 1987 NYSNA CONVENTION

A. Research Symposium

The Research Symposium, co-sponsored with the Foundation of The New York State Nurses Association, is scheduled from 8:30-11:45 on Friday morning, October 23, 1987.

B. Poster Session

Thirty-nine Poster Session abstracts were reviewed. Thirty-two were accepted, seven were rejected. Several of the rejected abstracts were recommended for resubmission when further progress is made on the research.

C. Council Booth

The Council members will be available again to provide research consultation to individuals who request assistance.

III. DISTINGUISHED NURSE RESEARCHER AWARD

The Council reviewed three nominees for the Distinguished Nurse Researcher Award granted by the Foundation of The New York State Nurses Association. One nominee was not considered because her materials arrived long after the deadline.

The Council has forwarded a recommendation to the Foundation Board of Trustees.

IV. JUNE JOURNAL

The Council reviewed The Journal. They thanked the co-editors and the staff of the Communications, Publications and Public Relations Department for the quality of the publication.



The form for submitting abstracts, and stating the criteria for acceptance of abstracts, is enclosed. If you are engaged in or have completed research since 1980, and have not submitted an abstract on it, we would like to encourage you to do so.

The purposes of the Clearinghouse are: to share with members of The New York State Nurses Association current nursing research being done by nurses and their colleagues in New York; to facilitate the networking of nurse researchers and to stimulate and encourage beginning researchers in nursing.

Acceptance of the abstract is based on a clear description of:

- (a) the purpose of the research;
- (b) hypothesis(es) or research questions;
- (c) relevance to nursing;
- (d) population or data source;
- (e) data collection methods;
- (f) methods of analysis;
- (g) research findings;
- (h) implications for nursing.

The abstract should be no longer than 300 words in length and fit on a single page. The reverse side of the form reporting the research may be used.

All abstracts must be received in our office by March 15, 1987 in order to be listed in the June 1987 issue of Journal.

Guidelines for Selection of Research Studies
for Inclusion in Poster Sessions

Sponsored by the Council on Nursing Research

The purpose of the Council on Nursing Research poster session is to facilitate discussion between individuals currently engaged in a research study and others with an interest in the subject. Since three key questions in research concern theory, methodology and findings, it is anticipated that presentations based on current research will focus on either new theoretical or methodological approaches and/or the results of the study.

Poster sessions allow those currently engaged in research to present their work in an informal setting utilizing poster boards or the media to present their major findings. Slide presentations are just one of a number of ways in which media may be used. In addition, each presenter in a poster session is expected to have one hundred (100) copies of abstracts and other appropriate information.

Presentations for inclusion in poster sessions will be selected by a panel of judges. The panel requires a single-spaced, 1 page typed abstract along with completion of the "Form for Reporting Research Effort Completed or in Progress." Abstracts should include:

1. Clearly stated purpose and/or hypothesis.
2. Adequate literature review which links current research to previous work on the subject.
3. Visible theoretical underpinnings.
4. Explicit research design including sample characteristics and size.
5. Evidence of adherence to ethical guidelines.
6. Results and implications.

To be considered, abstracts of work to be presented in the poster session should be sent by June 1, 1987 to: Council on Nursing Research, New York State Nurses Association, 2113 Western Avenue, Guilderland, New York 12084.

If accepted, guidelines for participation in the session will be sent.


The Council will again provide for nursing research consultation in a booth near the Poster Session.
