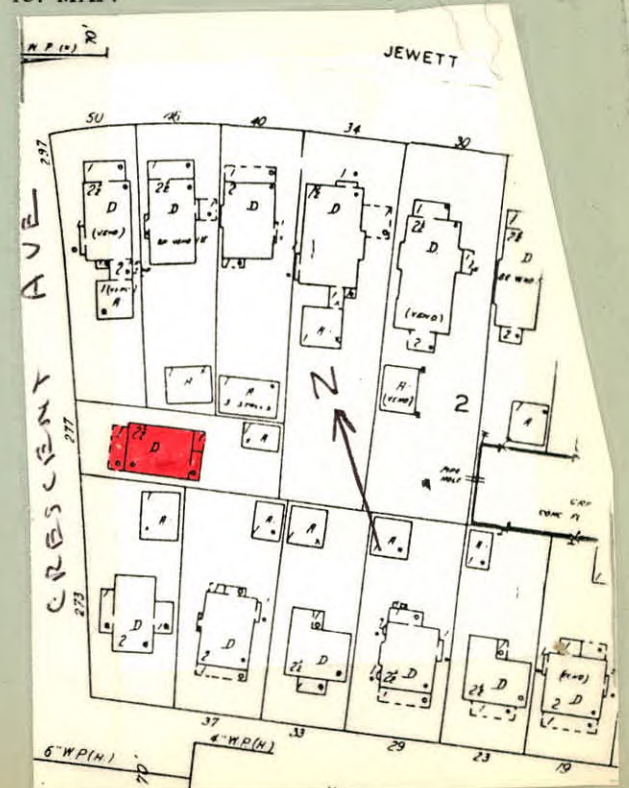

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized corner lot within Olmsted's Parkside subdivision. House is located three blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and southeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story with Craftsman and Prairie School styling. Side gable roof has bargeboard decorated with square motifs. Full-width hip roof porch with exposed rafter tails under eave. Tapered square columns with bracket supports. Stick balustrade. Diamond light wood paneled door flanked by 1/1 windows. First floor has a pair of single light windows with leaded transom.

SIGNIFICANCE

19. DATE OF INITIAL CONSTRUCTION: c. 1909 Shingled second floor. Second floor has a set of paired windows with diamond tracery

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: Typical vernacular form of Craftsman and Prairie style. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
