

B. Harriet Berliner Request

Executive Committee have little contact with long term facilities. Executive Committee did receive Department of Health regulations from February 1986 regarding physician assistants and nurse practitioners and would like clarification from NYSNA staff.

C. Advanced Practice Legislation

M. Callan shared a letter she received from California Nurses Association (CNA) clarifying their Nurse Practice Act. List of practice acts needed by Executive Committee for review was developed at 9/30 meeting, however without those minutes it could not be recalled what specific practice acts were requested. M. Callan and D. Plumadore will develop the list again and request that specific practice acts be sent to each Executive Committee Member for review. It was also reported that at this point, the Coalition of Nurse Practitioners has refused verbally to meat with NYSNA even with a facilitator. Apparently, the Coalition feels that the recently passed NYSNA Legislative Program inhibits compromise by NYSNA in this area.

The Committee suggested that after a written response is received from the Coalition; perhaps one could respond to the Coalition clarifying NYSNA's abilities while conforming to the Legislative Program.

Also, President Hunter has suggested that current and past members of the Executive Committee be brought together to discuss these issues and strategies. The Committee suggested that since these current and past members consist of 3 from Syracuse/Rochester area and 2 from Binghamton, that it might be less expensive to have the meeting in Syracuse. Also, if possible, it should be done prior to the February Functional Unit meeting.

D. 1988 Convention Suggestions

The Committee raised the feasibility of planning programs at Convention considering there is poor attendance.

E. 1988 Priorities

Advanced practice issues including:

- 1. Gather information from other states and how they legislatively handled and prescriptive authority.
- 2. Insurance and liability issues.



III. Minutes of the May 8-9, 1987 Meeting

These minutes were read and approved as written.

- IV. Business
  - A. Malpractice Insurance

Much discussion occurred related to the crisis in malpractice insurance for nurse practitioners with each member sharing experiences and ideas. Some nurse practitioners are continuing with McGinnis and Associates and paying the \$1500 premiums. Some nurse practitioners who are applying for the first time are having some success with Cotterell, Mitchell and Fifer at rates of only \$81. The Committee voted to have the Chairman write a letter to the New York State Insurance Commissioner urging a mutually agreeable resolution to this problem. The Chairman will consider making a statement during the Annual Report of the Functional Unit at Convention soliciting the support of the voting body by recognizing this as a professional nursing problem and not only a problem for nurse practitioners.

B. Letter for Dr. Novich, New York State Department of Health

A letter in response to the letter sent by the Chairman regarding the availability of immunizations for children in underserved areas was read. The Committee will continue to monitor the implementation of the Article 6 legislation, January 1988, which will provide vaccines for free clinics throughout New York State.

C. Legislative Update

Prescriptive Privilege Legislation

There was much discussion over the proposed Senate Bill S1314A. Chris Tofflemire spoke briefly with the Committee outlining the process at this time and NYSNA's strong opposition. Martha Orr also spoke with the Committee and reinforced the Association's opposition to the bill. Ms. Orr recommended that a concerted effort be made for the 1988 Legislative Year between NYSNA, the Coalition of Nurse Practitioners and the Medical Society to obtain prescriptive legislation. Diane Plumadore requested permission to attend the September 17-18 Board Meeting to address any questions the Board Members might have related to the letter sent by the Executive Committee in July. Permission was granted by Martha Orr, NYSNA Executive Director.

D. Convention 1987

The Committee recommended that the possibility of presenting an educational program at the Annual Meeting be investigated. Mel Callan suggested a forum in which both sides of the Advanced Nursing Practice Legislation be explored. Possible speakers suggested were: Bonnie Bullough of the University of Buffalo and Judy Rafson, Vice Chairman of ANA's Council on Primary Care Practitioners. It was felt that it was important to present the advantages as well as the disadvantages that other states have encountered in efforts to obtain credentialing for advance clinical practice. Staff will investigate feasibility of doing this.

## V. Other

A. Report from ANA's House of Delegates

Staff gave a brief report from the House of Delegates noting specifically the adoption of a Bylaws provision that will permit SNA's to offer membership to associate nurses and the adoption of scope of practice statement.
