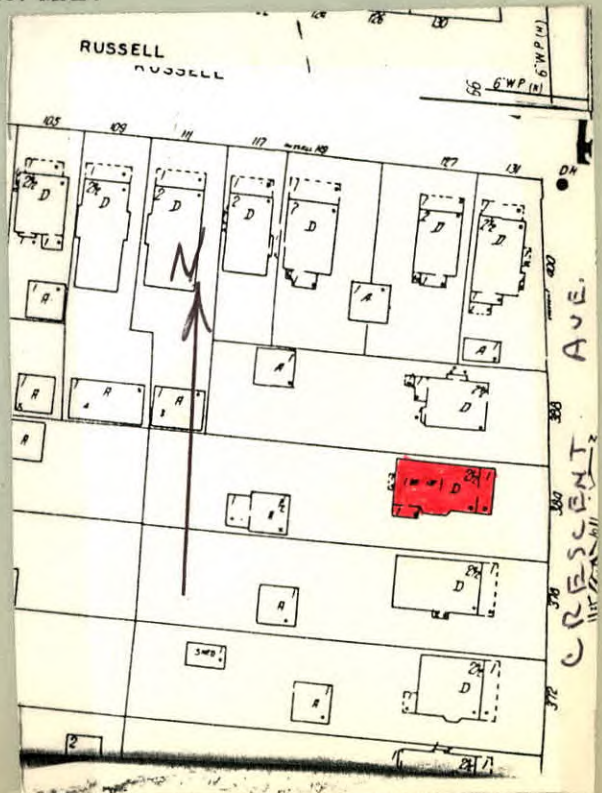

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located three blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):  
 Two and a half story with Queen Anne style influence. Front facing gable roof. Hip roof full-length porch with end pedimented gabled entrance. Brackets under gable cornice. Vine motif in tympanum. Glass and wood paneled door flanked by 1/1 windows. Porch has band of 1/1 windows. Second floor bowed bay. Center 1/1 window with leaded sidelights. Pilaster strip mullions.

19. DATE OF INITIAL CONSTRUCTION: c. 1905 1/1 windows in second floor. Pedimented gable, ARCHITECT: shingled, has brackets under cornice projection. Three-part 1/1 windows with curvilinear design under sill. Cornice window head with brackets.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: Gabled residential structure with overtones from the Queen Anne style. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
