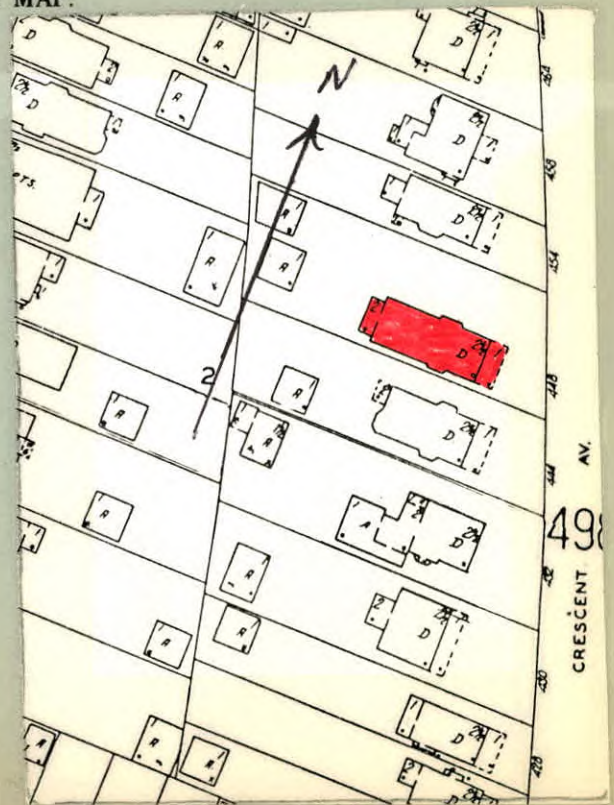

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located three blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

 Two and a half story American Four Square. Hip roof with extending eaves. Full-width deck roof porch has square brick piers and shingled rail. Three vertical light beveled glass door with leaded sidelights. Tri-part first floor window, single light center with leaded transom and sidelights. Semi-

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A typical American Four Square form with Craftsman style details. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
