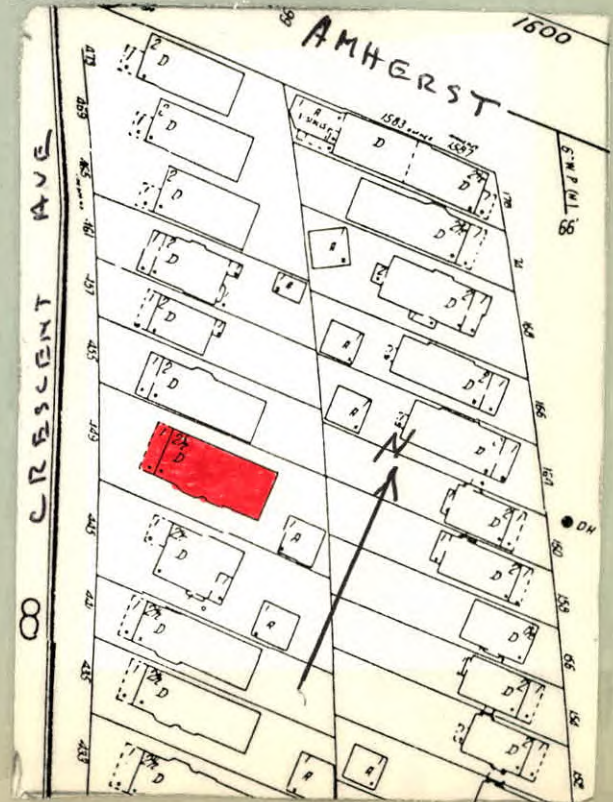

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located three blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and east of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):
 Two and a half story Colonial Revival style. Front facing gable roof. Full-width porch has paired fluted Doric columns, spindle balustrade and dentils under cornice. Wood paneled door with diamond tracery in glass panel. Leaded sidelights. Tri-part first floor window has single light center with leaded transom prism-shaped tracery in sides. Second floor paired

SIGNIFICANCE

19. DATE OF INITIAL CONSTRUCTION: 1908 semi-hexagonal bays have
 prism-shaped tracery in windows. Lighted wood
 ARCHITECT: paneled door. End fluted pilaster strips.
 BUILDER: Pedimented gable has brackets under projection.
Three windows, 12/1 center with 9/1 sides.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A simple Colonial Revival style situated on a narrow urban lot. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
