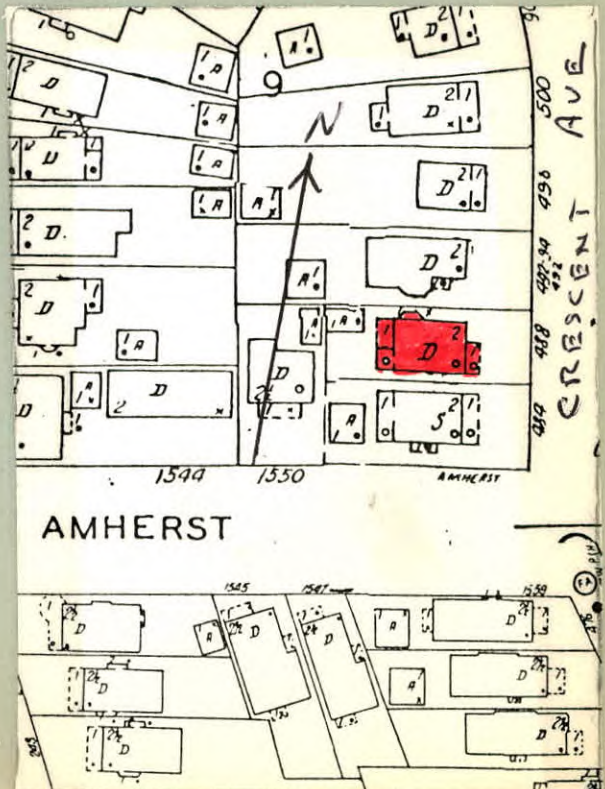

Building is situated on a standard sized corner lot within Olmsted's Parkside subdivision. House is located three blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and northeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two story frame American Foursquare. Gable roof. Three six light over single light windows in front gable. Eight light over single pane windows on front facade. Front porch has a hip roof, squared posts and modillion-like brackets in eaves. Gables and second floor are shingled. First floor is clapboard. Rectangular bay on the north side of the first floor. Stone foundation.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: Typical example of the American Foursquare style that was built in the Parkside neighborhood. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
