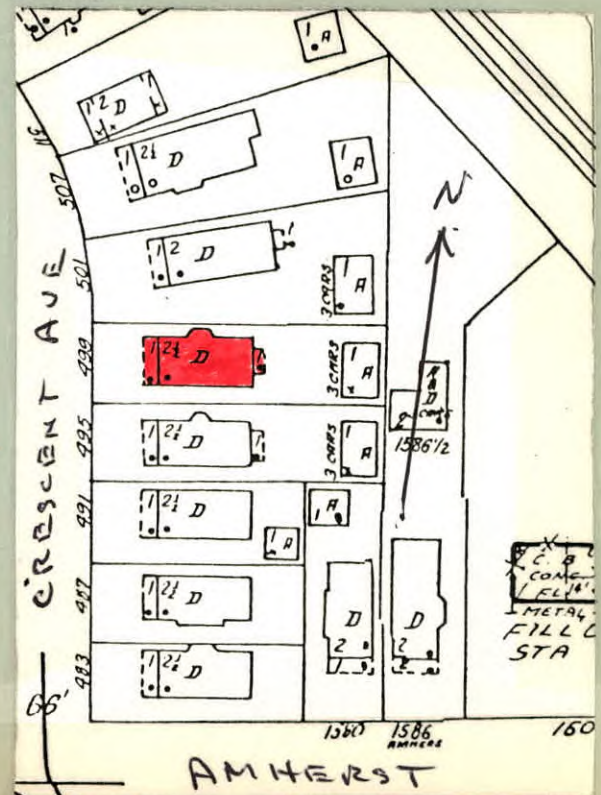

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located three blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and northeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two story frame American Four Square. Clipped gable roof with a gabled dormer with three single pane over single pane sash windows. Porch across front of house has tapered paneled posts and rubble stone piers and foundation. First floor porch has a stick balustrade and an entranceway with leaded glass sidelights. Second floor porch has shingled posts and a balustrade which is

half shingled and half stick. First floor of house is clapboard and the second floor is shingled.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: Good example of the American Four Square as it was built in the Parkside neighborhood. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
