Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located three blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and northeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):
 Two story frame American Four Square. Gable roof with two single pane sash windows in front gable. Porch across front of house has sixteen two pane over single pane windows and door with transom. Gable over entranceway. Polygonal bay towards rear of the first floor south facade. Second floor front facade SIGNIFICANCE has a rectangular bay on the north and a polygonal bay on the south. Stone

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: Good example of the American Four Square that was built in the Parkside neighborhood. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
