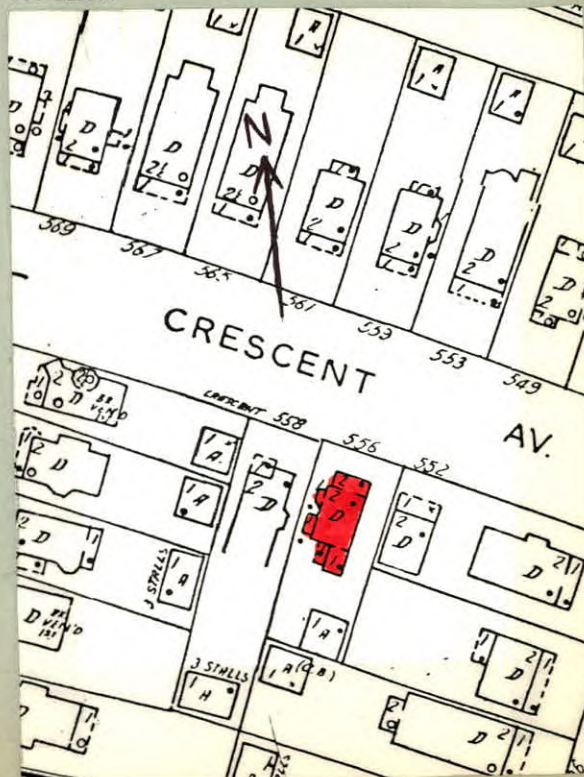

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Building is situated on a standard sized corner lot within Olmsted's Parkside subdivision. House is located three blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and northeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):
Two story frame American Four Square. Gable roof with flared eaves. Dormer with a hip roof with flared eaves on the east side of house. Rectangular bay with a hip roof on the first floor of the east facade. Two story porch with a gable roof with flared eaves across front of house. Four two-story squared paneled **SIGNIFICANCE** columns in porch. Second floor porch is enclosed with

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: Typical example of the American Four Square that was built in the Parkside neighborhood. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside," By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
