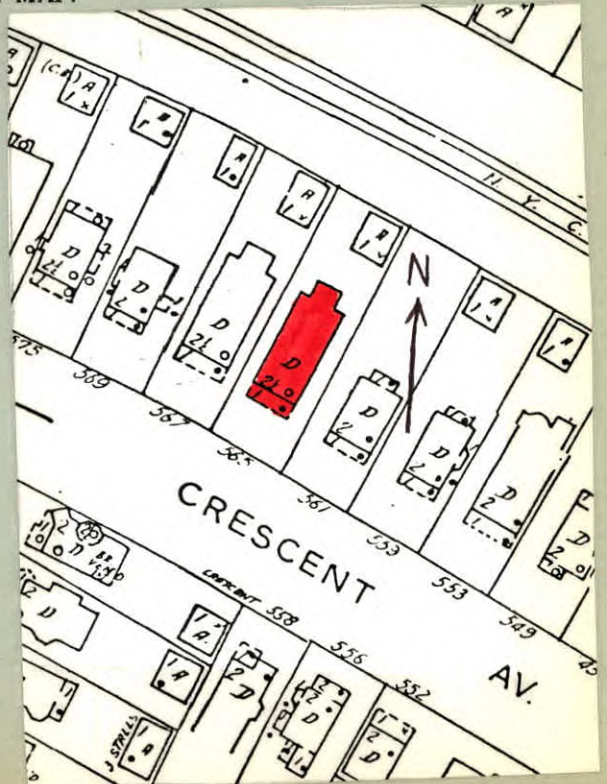

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and northeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

Two and a half story American Four Square. Hip roof with curved knee braces under extending eaves. Full-width deck roof porch with exposed rafter tails. End brick piers. Glass and wood paneled door with sidelights. Three-part window, single lights with leaded transom. Second floor semi-hexagonal bay with 6/1 windows. Lighted porch door. Gable roof dormer with

19. DATE OF INITIAL CONSTRUCTION: c. 1914 bargeboard and stick styling in top of gable. Three-part window. 3 lights over 1 pediment shaped window head.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: Typical American Four Square. Similar to 567 Crescent in building plan. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
