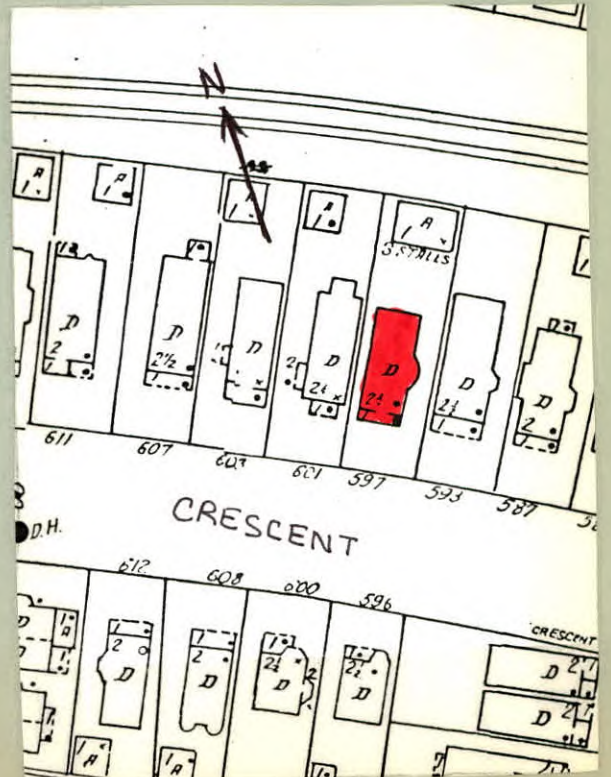

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and northeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):  
Two and a half story American Four Square with Colonial Revival styling. Hip roof with end brackets under extending eaves. Full-width porch, flat roof partially enclosed. Tri-part window, single light with 4 light sidelights. Window shutters. Recessed entrance. Wood paneled door flanked by round arched window with arched tracery. Second floor semi-hexagonal bay

**SIGNIFICANCE**  
19. DATE OF INITIAL CONSTRUCTION: c. 1915 with 1/1 windows. Glass and wood paneled door.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: An American Four Square with minimum application of Colonial Revival style details. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
