

17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS: (Indicate if building or structure is in an historic district)

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and northeast of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known): Two and a half story frame house with front facing gable roof. Full-width deck roof porch partially enclosed has brick base and end piers topped with square supports. Horizontal band of windows, single light with 3-light transom. Recessed entrance has three vertical light beveled glass door with leaded sidelights. <u>SIGNIFICANCE</u> Second floor semi-hexagonal bay with 1/1 windows. 19. DATE OF INITIAL CONSTRUCTION: 1919 Double sash porch door with center panel decorated with diamond tracery. Pedimented

	gable, projecting, has three-part 1/1 window.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A gabled frame with Prairie School style porch. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
