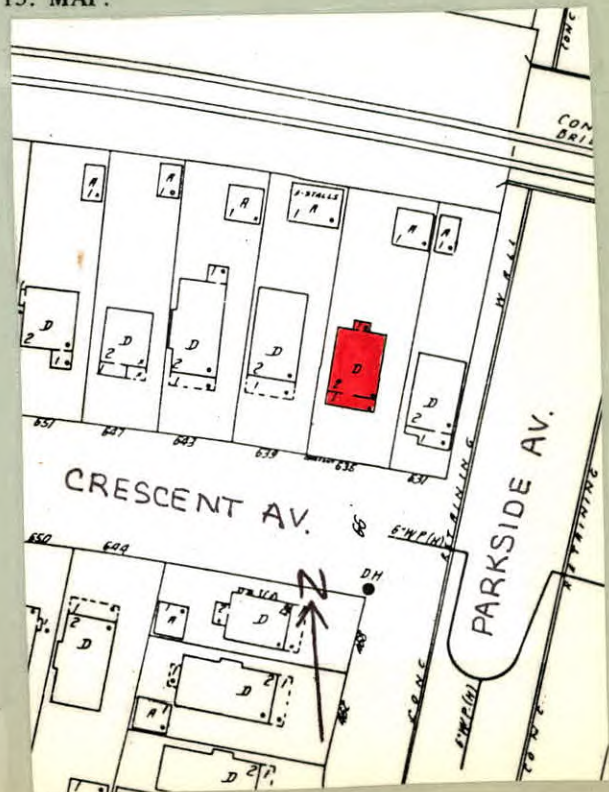

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and north of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):  
 Two and a half story residential structure. Front facing gable roof, bargeboard and extending eaves. Full-width gabled porch. Doric pilaster strips flank horizontal band of four 8/1 light windows. Stick styling in gable. Bargeboard with flared ends. Shingled second floor. Second floor 9/1 windows. Second floor SIGNIFICANCE capped by low-relief pediment with keystone. Gable
19. DATE OF INITIAL CONSTRUCTION: c. 1920 has a pair of 9/1 windows.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: A residential structure with simplified Prairie School influence. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
