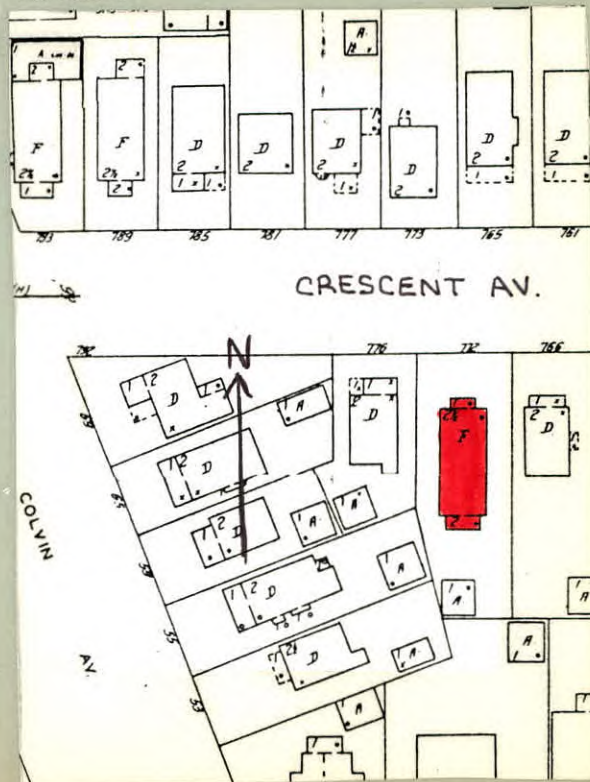

Building is situated on a standard sized lot within Olmsted's Parkside subdivision. House is located two blocks from Delaware Park, which was designed by Olmsted and is listed on the National Register, and north of the Zoo.

18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):
 Two and a half story residence with front facing clipped gable roof. Partial-width enclosed entrance porch. Tri-part 1/1 windows with multi-light transom. Doric end pilaster strips. Glass paneled door with 1/1 sidelights and transom. Upper porch has double-sash multi-light doors. Second floor band course.

SIGNIFICANCE 8/1 light square-headed windows. Shingled gable. Tri-part 6/1 light window.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE: Verticality of the Prairie School combined with Colonial Revival style details are illustrated on this residential structure. Crescent Avenue is the longest curvilinear street in the Parkside subdivision, stretching from Humboldt Avenue to Colvin Street. This street appears on Olmsted's early 1870's maps of "The Parkside." By the 1880's plans for Crescent Avenue had been modified by Olmsted to its current form. Portions of the street were deeded to the city by five different owners over a span of five years, beginning in 1887 near Humboldt and ending in 1892 near Colvin. Crescent Avenue begins and ends within the Parkside subdivision, following Olmsted's rule that a suburban neighborhood street "not lead with special directness toward the town."
